Memorandum of Understanding

LEPL - Batumi Art State Teaching University, represented by the rector Maia TCHITCHILEISHVILI, on the one hand, and Trabzon University represented by the rector Prof. Dr. Emin AŞIKKUTLU, on the other hand, (Hereinafter, collectively referred to as the "parties"), recognizing the principles of cooperation and mutual respect and agree on collaboration in the field of higher education to support students and academic staff exchange programs and their participation in educational, scientific and creative projects.

Objectives of the memorandum of understanding

- Implementation of educational activities.
- Supporting scientific research activities;
- Establishing cultural-creative relations.

Article 1

- 1.1. The sides are following the agreed policy to share experience between universities in educational, scientific and creative fields:
 - To organize and conduct master classes, seminars, conferences, workshops, trainings and public lectures.
 - To give consultations in order to launch educational programs.
 - To implement joint educational and creative project.
- 1.2. The sides will give consultations to each other in order to involve the students of Batumi Arts State University in student and academic staff exchange and internship programs;
- 1.3. The sides will take part in students' creative projects: festivals, contests, concerts, performances, exhibitions, etc;

1.4. The sides will work out students and young specialists' summer school programs;

- 1.5. The sides will take part in joint international grant projects;
- 1.6. Organizational and financial engagements including involvement in exchange and creativeprojects will be additionally discussed by the sides.

Article 2

- 2.1. This memorandum of understanding each side is able to offer changes and additions on the basis of bilateralagreement;
- 2.2. Relationship specificity among the sides, which isn't defined in the memorandum, is arranged with bilateral agreement.

Article 3

- 3.1. Moot points connected with fulfilling of this memorandum will be settled by the help of consultations and negotiations;
- 3.2. This memorandum is valid after it is signed by the sides and acts until the other decisions won't be made by the sides;
- 3.3. This Memorandum of Understanding is concluded with a view to enhancing and developing cooperation between the Participants and does not constitute an international agreement binding upon the States of the Participants under international law. No provision of this Memorandum of Understanding shall be construed to create legal rights or obligations for the States of the Participants
- 3.4. Mutual Collaboration Memorandum is composed in equal juridical duplicate, each copy will be given to the sides.
